

SAMSUNG HA SPRING FOR SOMETHING NEW OFFER TERMS AND CONDITIONS

Offer description. Purchase a combination of two (2) or more eligible Samsung Home Appliances (Refrigerators, Ranges, Dishwashers, Wall Ovens, Cooktops, and Range Hoods) (“Qualifying Purchase”) (see Appendix below for list of eligible products) from a participating retailer (in store or online) and receive a Visa® Reward Card (“Offer Item”) based on the number of eligible products purchased, after submitting valid offer claim as described below. Purchase two (2) qualifying products in one transaction and get a \$200 Visa Reward card after submitting valid offer claim.
