

**SAMSUNG TAB S3 GOOGLE PLAY OFFER**  
**TERMS AND CONDITIONS**

**OPEN TO ALL LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA, PUERTO RICO, AND THE US VIRGIN ISLANDS, WHO ARE 18 YEARS OF AGE OR OLDER.**

**VOID WHEREVER PROHIBITED OR RESTRICTED BY LAW.**

**VALID ONLY WHILE SUPPLIES LAST.**

- 1. ELIGIBILITY:** The Samsung Tab S3 Google Play Offer (the “Offer”) is open to legal residents of the fifty (50) United States, the District of Columbia, Puerto Rico, and the US Virgin Islands, who are at least eighteen (18) years old and make a Qualifying Purchase (defined below in Section 3.A). Void elsewhere and where prohibited or restricted by law. Individuals who meet these eligibility requirements are collectively referred to herein as “Participants.” Administrator reserves the right to request Participants to provide verification of identity. Participation constitutes a Participant’s full and unconditional agreement to these Terms and Conditions and Sponsor’s and Administrator’s decisions, which are final and binding in all matters related to the Offer.
- 2. THE PURCHASE PERIOD AND REDEMPTION PERIOD:** The “Purchase Period” begins on June 23, 2017 and ends on June 30, 2019 or while supplies last, whichever occurs first. A valid “Offer Claim Form” must be submitted online between June 23, 2017 at 10:00 AM Eastern Time (“ET”) and August 31, 2019 at 11:59:59 PM ET, or while supplies last, whichever occurs first (“Redemption Period”). See below for instructions on how to redeem the Offer.
- 3. HOW TO PARTICIPATE AND RECEIVE GOOGLE PLAY CREDIT:** A Participant must:
  - A.** During the Purchase Period, purchase a Samsung Galaxy Tab S3 (SM-T820NZKMXAR and SM-T820NZSMXAR) on a device payment plan or outright purchase at full retail price from a participating retailer (“Qualifying Purchase”). **Qualifying Purchase cannot be used to participate in more than one (1) Samsung offer, rebate or promotion;** and
  - B.** During the Redemption Period, submit a valid Offer Claim Form and valid receipt online by visiting <https://samsungpromotions.com/TabS3> (“Website”) and complete all of the following steps:
    1. Enter the requested information on the official Offer Claim Form, which includes, but is not limited to: Participant’s full name (no initials), complete mailing address (no P.O. Boxes), valid e-mail address, a contact mobile telephone number, and confirmation that he/she is at least 18 years of age. Participants will not be allowed to change their mailing address or e-mail address. Note: Participants full name on the official Offer Claim Form must match the name on the valid original Qualifying Purchase receipt submitted.
    2. Enter the date of the Qualifying Purchase.
    3. Enter the serial number of the Qualifying Purchase.
    4. Submit his/her original register receipt on the Website documenting the Qualifying Purchase by following the on-screen prompts to upload a photograph of the

original register receipt showing the Qualifying Purchase. It is recommended that Participant first print his/her complete name on the original register receipt, sign and date the receipt, and circle the Qualifying Purchase on the receipt before uploading the receipt. The file must be in .JPEG, .JPG, or .GIF format and may not exceed 8 MB.

**Offer Claim Forms and valid receipt must be submitted by 11:59:59 PM ET on August 31, 2019, to be valid.**

If more than one (1) Qualifying Purchase is included on an individual receipt, a Participant will be able to then submit the additional Qualifying Purchase information, including the serial number and of the additional devices included on the uploaded Qualifying Purchase receipt. If a Participant purchased additional Qualifying Purchases in separate transactions, a separate Offer Claim Form must be submitted.

A Qualifying Purchase must occur during the Purchase Period. Offer Claim Forms and receipts must be submitted during the Redemption Period and include all requested information listed in these Official Terms and Conditions and the Offer Claim Form. GOOGLE PLAY CREDIT DETAILS:** Upon verification of the Offer Claim Form and receipt (determined by Sponsor in its sole discretion), the Participant will receive one (1) \$20 Google Play credit, while supplies last. No more than forty thousand (40,000) Google Play credits will be available in the Offer. Samsung reserves the right to substitute a Google Play credit for another item of equal or greater value in the event of item unavailability.

Google Play credit must be added to a Google Payments account within sixty (60) days of receipt but no later than December 31, 2019. Once added, credit must be used on Google Play within one (1) year of inputting the code but no later than December 31, 2020. Google Play credit is not reloadable and has no cash value. Must have Google Payments account to

claim Google Play credit; certain subscriptions excluded. See the [Google Play Promotional Balance Terms](#) and [Google Play Terms](#) for more information. Google Play credits will be emailed to Participants within approximately 4-6 weeks after verification of Offer Claim Form/receipt and compliance with these Terms and Conditions.
